Cheyenne Police Chief Bob Fecht's alma mater has been closed by the State of Mississippi! *Lacrosse University was never authorized to grant degrees!*

We apologize for any inconvenience, but in order to meet the needs of our registered students and continue to offer the assistance they need, we must maintain the proper student to staff ratio. Again, thank you for your interest in Lacrosse and we hope to be able to meet your needs in the future.
