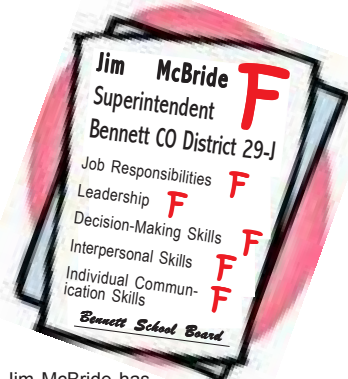
had to choose a new, albeit interim Superintendent of Public Instruction?
